What is the overall <a href="#">deductible</a> ?	<b>\$300</b> /individual or <b>\$300</b> /family for In- <a href="#">Network Providers</a> . <b>\$400</b> /individual or <b>\$800</b> /family for Out-of- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> , Primary Care visit, <a href="#">Specialist</a> visit, lab and x-ray, emergency care, ambulance travel, pre and post natal maternity services, allergy serum and injections, infusion therapy, chemotherapy, radiation therapy, dialysis for In- <a href="#">Network Providers</a> . Vision exam for In- <a href="#">Network Providers</a> and for Out-of- <a href="#">Network Providers</a> .
